In accordance with the requirements of the Personal Data Protection Act of the Republic of China, we notify of the following matters: 因應中華民國個人資料保護法(以下簡稱「個資法」)之要求，本文件包含下開資訊：

*In this document, the term "you" refers to individuals whose Personal Data (as defined below) we process, such as individuals who work for or are otherwise engaged by, or interact with, our clients, their affiliates or other third parties with which we have a current or former relationship, and "Bank of America Corporation" or "we" or "us" refers to the Bank of America Corporation company listed above (Merrill Lynch Securities (Taiwan) Limited) with which you have entered or are seeking to enter into a client relationship and as applicable other companies within Bank of America Corporation. This notice also explains how we collect, use, share and protect personal data from registrants for events that these entities host. See relevant sections on event management and execution.*

本文件中的「您」係指其個人資料（定義如後）受到我們處理的個人（例如：為我們客戶、其關係企業、或目前或過去曾與我們有往來關係之其他第三方 工作或以其他方式受其雇用、或與其互動之個人）；「美國銀行控股公司」或「我們」則指您現在或即將建立客戶關係之美林證券股份有限公司，或美國銀行控股公司下屬 之其他企業。本份聲明亦解釋我們如何蒐集、使用、分享及保護這些實體主辦的活動註冊者個人資料。請參見活動管理和執行相關段落。

We collect, use and process various types of personal data to the extent appropriate for our relationship with each individual. - Because it is necessary to ensure the site works as intended, such as performing authentication within a secured site. Without this information, some services you have asked for cannot be provided; for example, without cookies or similar tracking technology, you will not be able to access a secured area within this site that requires authentication to assist in detecting and preventing fraud, identity theft and other risks to you or Bank of America.

Appropriate employees are authorised to access personal data for legitimate and specified business purposes. Our employees are bound by a code of ethics and other internal policies that require confidential treatment of personal data and are subject to disciplinary action if they fail to follow such requirements. Please do not send us any Personal Data which would be categorized as special data under the Personal Data Protection Act of the Republic of China (e.g., comprising medical records, medical treatment, genetic information, sexual orientation or sexual practices, health examination and criminal records) (“Special Data”) through the Services or otherwise, unless we specifically request this information from you or make a due diligence enquiry of you where the response necessitates you disclosing Special Data to us. Make an inquiry about, request to review or request a copy of the personal data (we may collect reasonable fees);</li> <li>2. Request to add or amend the personal data if inaccurate or incomplete (with proper explanation);</li> <li>3. Request to terminate collection, use or processing of the personal data or to delete the personal data (to the extent that such personal data is not necessary to conduct business or we are otherwise legally entitled to retain same).</li> </ol> <p>If you would like to request or exercise any of your rights stated above, you may contact us by emailing <a href="mailto:individualrightsrequests@bofa.com">individualrightsrequests@bofa.com</a>. We will respond to your request as consistent with applicable law.</p> <p>For your protection, we may only implement requests with respect to the Personal Data associated with the particular email address that you use to send us your request, and we may need to verify your identity before implementing your request. We will try to comply with your request as soon as reasonably practicable.</p> <p>Please note that we may need to retain certain information for recordkeeping purposes and/or to complete any transactions that you began prior to requesting a change or deletion. If individuals choose to not provide, to limit or to withdraw consent to collection, use, processing or sharing of personal data, we may not be able to provide clients with certain products or Services.</p> <p>您有權反對我們對個人資料進行蒐集、利用、處理及共用。若您選擇不提供、限制或撤回您對蒐集、利用、處理或共用個人資料的同意，可能導致我們無法為您提供特定資訊、報價或服務。</p>

If you provide us with personal data of third parties (including but not limited to your representatives, employees, officers, directors, shareholders or clients, or relatives, beneficiaries and guardians), you agree to inform such third parties and obtain their consent to the processing of such personal data in accordance with this document and any other applicable laws and regulations.
