1 Entity Details

1.1 BofA Securities Europe SA (“BofASE”)

BofASE is a *société anonyme* incorporated under the laws of France registered with the RCS Paris under number 842 602 690, with its registered address and principal place of business in France at 51 rue la Boétie, 75008, Paris. BofASE is authorised as an investment services provider by the *Autorité de contrôle prudentiel et de résolution* and regulated by the *Autorité de contrôle prudentiel et de résolution* and the *Autorité des marchés financiers*.
