

Global Equities – Investable Indices Restatement Notice

NOTICE OF RESTATEMENT OF INDEX CLOSING LEVELS

Related to: The BofA Indices set out in Annex A (the "Impacted Indices") and the BofA Indices using the Impacted Indices as underlying components set out in Annex B (the "Impacted Composite Indices")

Dated: 15th May, 2023

Merrill Lynch International ("**MLI**"), the Benchmark Administrator and Index Calculation Agent in respect of the Impacted Indices and Impacted Composite Indices, has determined that the Index Closing Levels, in respect of the Index Calculation Days of 14th April 2023, 17th April 2023, 18th April 2023, 19th April 2023, 20th April 2023, 21st April 2023, and 24th April 2023 (the "**Impacted Index Calculation Days**") need to be restated for the Impacted Indices and Impacted Composite Indices, in order to reflect the delayed application of the correct share identifiers for URW NA following the late notification by Bloomberg of a reclassification corporate action that took place on 13th April.

On 14th April 2023, URW NA (Unibail-Rodamco-Westfield Group), an underlying component of the Impacted Indices, underwent a reclassification as a result of a change in its country of listing. However, Bloomberg delayed the communication of this reclassification with the result that the reclassification was not identified and implemented by the Index Calculation Agent for the Impacted Indices until the omission was discovered on 25th April 2023. Until this date, the incorrect share identifiers were used for pricing whereupon they were updated on such date. As such, the levels for the Impacted Indices for the Impacted Index Calculation Days above were incorrect as they did not take into account the reclassification and accordingly the update to the share identifiers used for pricing.

This notice is therefore to advise that the index closing levels for the Impacted Indices were restated for the Impacted Index Calculation Days to reflect the updated share identifiers. This affected the index closing levels of the Impacted Indices and therefore the index closing levels of the Impacted Composite Indices.

Table 1 below sets out, in respect of each Impacted Index, Impacted Composite Index and Impacted Index Calculation Day, the original and restated Index Closing Levels (the "Original Index Closing Level" and the "Restated Index Closing Level" respectively) for the Impacted Indices and the Impacted Composite Indices.

The Restated Index Closing Levels are available on Bloomberg under the Bloomberg Tickers above for each of the Impacted Indices and Impacted Composite Indices.

Capitalized terms not otherwise defined herein shall have the meaning given to them in the relevant index rulebook for the Impacted Index (the "Index Rulebook"). To the extent that the Index Rulebook instead uses the term "Benchmark Sponsor" and "Index Committee" to describe the functions of the Benchmark Administrator and Equities Index Forum, respectively, such corresponding terms shall be read and construed accordingly for purposes of this Notice. This notice and the actions described herein with respect to the Index is pursuant to, and subject to the conditions and disclaimers in, the respective Index Rulebook.
