**円貨建:**当期末残高は 69,756 百万円となり前年同期比 51,051 百万円減少(△42%)した。事業法人向けシンジケートローンの貸付債権譲渡及び返済が主な要因である。

**外貨建:**当期末残高は 153,938 百万円となり前年同期比 96,811 百万円減少(△39%)した。事業法人向け証書貸付案件の返済が主な要因である。

**円貨建:**当期末残高は275,296百万円となり前年同期比 134,648百万円減少(△33%)した。期中平残ベースでは 259,252百万円となり前年同期比36,381百万円減少(△12%)した。末残の減少はグループ会社からの預金の減少が主な要因である。

**外貨建:**当期末残高は38,922百万円となり前年同期比 56,840百万円減少(△59%)した。期中平残ベースでは 66,926百万円となり前年同期比11,774百万円減少(△15%)した。末残の減少は居住者からの米ドル建預金の減少が主な要因である。

### 3) 輸出入為替の取扱状況

**輸出信用状接受高(日本国外からの積出し分を含む)**は、前年同期比 43%減少した(当期 93 百万米ドル、前年同期 164 百万米ドル)。地域別では中南米地域向け(前年同期比△14%)が自動車・トラック輸出案件を中心に全体シェアの 84%を占め、アジア向け(前年同期比△79%)のシェアは 16%となった。

**信用状付輸出手形取扱高(日本国外からの積出し分を含む)**は、商社等顧客からの直接持込が前年同期比で 90%減少し、全体では前年同期比 69%減少した(当期 104 百万米ドル、前年同期 338 百万米ドル)。仕向地別では中南米向け(前年同期比△18%)は自動車やトラックの輸出等を中心に全体シェアの 73%のシェアとなり、アジア向けの輸出案件(前年同期比△88%)は 27%となった。

資金運用収益 当期資金運用収益は 5,647 百万円(前年同期比 $\Delta$ 3,886 百万円、 $\Delta$ 40.77%)となった。

貸出金利息が 5,893 百万円(前年同期比 $\Delta$ 2,402 百万円、 $\Delta$ 28.96%)、および本支店為替尻受取利息が 17 百万円(前年同期比 $\Delta$ 627 百万円、 $\Delta$ 97.35%)となったこと等による。

資金調達費用 当期資金調達費用は 3,176 百万円(前年同期比 $\Delta$ 7,634 百万円、 $\Delta$ 70.62%)となった。

主に本支店為替尻支払利息が 3,576 百万円(前年同期比 $\Delta$ 6,671 百万円、 $\Delta$ 65.10%)となったことによる。

資金利益 資金調達費用を上回る資金運用収益により、資金利益は 2,470 百万円(前年同期比+3,748 百万円、+293.37%)となった。

役務取引等収益・費用 送金ビジネスによる受入為替手数料が 1,612 百万円(前年同期比+99 百万円、+6.56%)となり、その他の受入手数料が 1,655 百万円(前年同期比+50 百万円、+3.18%)となったことから、役務取引等収益は 3,267 百万円(前年同期比+150 百万円、+4.82%)となった。役務取引等費用 1,333 百万円(前年同期比 $\Delta$ 697 百万円、 $\Delta$ 34.35%)を差し引いた役務取引等利益は 1,934 百万円(前年同期比+848 百万円、+78.08%)となった。

その他業務収益・費用 外国為替売買益は 4,025 百万円(前年同期比 $\Delta$ 6,426 百万円、 $\Delta$ 61.48%)となり、その他業務利益は、3,981 百万円(前年同期比 $\Delta$ 6,517 百万円、 $\Delta$ 62.70%)となった。

営業経費 人件費は 1,158 百万円(前年同期比 $\Delta$ 59 百万円、 $\Delta$ 4.91%)、物件費は 3,623 百万円(前年同期比 $\Delta$ 141 百万円、 $\Delta$ 3.75%)となり、営業経費は 4,991 百万円(前年同期比 $\Delta$ 167 百万円、 $\Delta$ 3.75%)となった。

## 2020年12月期の業績の概要

バンク・オブ・アメリカ・エヌ・エイの2020年12月期の受取利息は、貸出金及びリース金融に対する利息及び手数料を中心として46,439百万ドルを計上し、支払利息控除後の正味受取利息は43,753百万ドルの収益となった。利息外収益は、サービス手数料等を中心として23,521百万ドルとなり、正味受取利息と合わせた収益合計は支払利息控除67,274百万ドルの収益となった。一方、貸倒引当金繰入額、人件費を中心とした利息外費用を、それぞれ10,607百万ドル、39,051百万ドル計上した結果、税引前当期純利益は17,596百万ドルとなり、法人所得税控除後の当期純利益は14,298百万ドルの利益となった（対前期比12,458百万ドルの減益）。

バンク・オブ・アメリカ・エヌ・エイの2020年12月期末の資産合計は、9,205億ドルの貸出金及びリース金融残高を中心として2兆2,588億ドルとなった（対前期末比4,058億ドルの増加）。同期末の負債残高は、1兆9,064億ドルの預金を中心として2兆402億ドルとなった（対前期末比3,993億ドルの増加）。同期末の株主持分合計は、2,186億ドルとなった。
